The Partnership provides free technical assistance, research, training, and analysis to help communities pass strong local tobacco ordinances that are both effective and legally sound.





FREQUENTLY ASKED QUESTIONS

Is SB793 in effect?

Yes.

SB793 came into force in December, 2022. Flavored tobacco products* may not be sold.





FREQUENTLY ASKED QUESTIONS

Is SB793 in effect?

Flavored shisha/hookah tobacco may be sold in hookah tobacco retail locations;

Flavored premium cigars may be sold and consumed in SB793 came into force in December, 2022. Flavored tobacco products* may not be sold. Flavored premium cigars and loose-leaf tobacco may be sold.



FREQUENTLY ASKED QUESTIONS

Is SB793 preemptive?

No.

Local jurisdictions may enact stricter regulations, including closing exemptions.





FREQUENTLY ASKED QUESTIONS Does SB793 restrict online orders?

No.*

SB793 is specific to California-based retailers.

Direct-to-consumer delivery from an out-of-state retailer is not covered.

FREQUENTLY ASKED QUESTIONS But what about online order + store pickup?

...maybe.

The question turns on where the "sale" occurs, and there's a good argument that a sale is only complete when a purchased product is received. If that occurs at a California location,

SB793 might apply.

FREQUENTLY ASKED QUESTIONS Does SB793 cover additives?

Yes.

SB793 prohibits "tobacco product flavor enhancers", whether made by the manufacturer or a thirdparty.

FREQUENTLY ASKED QUESTIONS *Does SB793 cover sensations?*


...maybe.

Sensations are not mentioned in the law. But are they distinguishable *like* a taste or aroma?

FREQUENTLY ASKED QUESTIONS Does SB793 cover cannabis?

...maybe.

But the DCC has a regulation prohibiting flavored inhaled cannabis products.
