<sup>2</sup> As used in this table, *e-cigarette* broadly refers to any product, and its component parts and accessories, that contains nicotine and/or other substances intended for use in the form of an aerosol, often referred to as vapor.

\* Retailers are required to obtain a license to sell e-cigarette liquid, but not e-cigarette devices themselves.
